**Circular No. RDPS/2021-22/41**  
(For Parents of Students of Classes VI-VIII) (session 2021-22)

Dear Parent(s)

The Directorate of Education vide its order no. DE.15(114)/PSB/2021/2165-2174 dated 01.07.2021 in pursuance of Hon'ble High Court order dated 31.05.2021 in WP(C) 7526/2020 and Division Bench order dated 07.06.2021 in LPA 184/2021 has directed the management of Unaided Private Schools who are the members of Action Committee of Unaided Private Recognized School to comply with the following directions:

1. To collect annual fees from the students as fixed under DSEA&R, 1973 for academic year 2020-21 but by providing deduction of 15% on that amount in lieu of unutilized facility by the students during the relevant period for academic year 2021-22. An illustration for calculating annual fees has also been provided by D.O.E. in the above said order.
2. That pursuant to the order passed by the Division Bench of the Hon'ble High Court of Delhi in LPA No. 184/2021, the above arrangement will be applicable in respect of collection of fees for the academic year 2021- 22, as is payable by students of the concerned school as and when it becomes due and payable.

Hence, it is intimated that the following amount shall be payable towards arrears of Annual Fees for the period from 01.04.2020 to 31.03.2021 as under:

The above amount of arrears for the period from 01.04.2021 to 30.06.2021 will be payable in 6 equal monthly instalments of Rs.43/- each w.e.f. July, 2021 till December, 2021 along with the monthly fees of Rs.3147/-.

Hence, you are intimated that the monthly fee bill for the month of July, 2021 till December, 2021 will be raised comprising of monthly fees of Rs.3147/- + arrears of Rs.43/- for the period from 01.04.2021 to 30.06.2021 (Table-II)+ arrears of Rs.172/- for the year 2020-21 (Table-I) total amount payable will be Rs. 3362/- each month.
