Dear Parent(s)

The Directorate of Education vide its order dated 18.04.2020 and 28.08.2020 directed the unaided recognized private schools to charge only monthly tuition fee and collection of Annual Charges & Development Fee was not permitted till that time the schools are physically opened. The school in compliance of the said orders have not charged Annual Charges and Development Fee for the period from 01.04.2020 till 30.06.2021.

The Hon'ble High Court of Delhi vide its judgment/order dated 31.05.2021 in WP(C) 7526/2020 - Action Committee Unaided Recognized Private Schools Vs. Dte. of Education has declared the above orders as illegal and ultra vires of the powers of Director of Education under DSE Act & Rules and the orders to that extent has been quashed.

The Hon'ble High Court of Delhi, further, vide its above said order permitted the unaided recognized private schools to collect the Annual Charges and Development Fee for theperiod from 01.04.2020 to 31.03.2021 in 6 monthly instalments by providing deduction of 15% on the said amount in lieu of unutilized facility by the students during the above mentioned period.

It was, further, directed that the above arrangements will be affect collection of fees for academic year 2021-22, as is payable by the students of concerned school as and when it becomes due and payable.

The Hon'ble High Court has also permitted to collect the Annual Charges and Development Fee for the academic year 2021-22 as and when it becomes due and payable.

Hence, it is intimated that the following amount shall be payable towards arrears of Annual Charges and Development Fee for the period from 01.04.2020 to 31.03.2021 as under:
